The survey was due in October. • Mr. Serene briefed that the following water tests had been performed: <ul style="list-style-type: none"> ○ Microbial Testing <ul style="list-style-type: none"> ▪ August 29 2024 – Chlorine residual level at 1.66 mg/l and absent coliform. <p>Note: .2 to 1.0 milligram/liter is considered normal for chlorine residual levels (TCEQ finds up to 4.0 acceptable for chlorine residual).</p>
